5.0 REPORT, DISCUSSION AND POSSIBLE ACTION ITEMS

5.1 Report, discussion and possible action to approve Participation and Memorandum of Understanding for State's "Race to the Top" Initiative.

Report by Dorma Baker, Superintendent.

Dorma Baker explained the initiative and its timeline: by December 31, districts should submit their intent to apply; by January 8, districts must submit their memorandums of understanding. There is no meeting required for the approval of the MOU.

The rationale for the MOU has four components: 1) national core standards for the state to align with national standards; 2) data systems implemented to monitor and inform instruction; 3) state approach to lowest performing schools; and 4) great teachers and leaders. The fourth component, Dorma

believes, will be the most challenging to implement due to contracts and collective bargaining agreements.

Board participated with comments, concerns and questions.

Trustee Turley moved to approve the MOU for Race to the Top initiative. Trustee Keegan seconded the motion requesting that the Superintendent and the Board President sign the agreement. Trustee Turley amended the motion to include trustee Keegan's addition.

The Board participated with additional comments and concerns.

The motion passed 6/0/1 (Osmundson absent).
