### 3.2 Welcome by Board President

Trustees Kim De Serpa, Sandra Nichols and President Leslie De Rose were present. Trustee Willie Yahiro was absent. Trustees Doug Keegan, Karen Osmundson and Jeff Ursino were away from their seats for some time.

### 3.3 Superintendent Comments

Dorma Baker followed up to some of the student comments from last week. Regarding Renaissance High and their comment on lack of food, she noted that she had spoken to the director who will visit the site to make sure the process is effective to be able to serve all students on campus. Regarding comment on closed bathrooms at Pajaro Valley High, she noted that there are times when it is necessary to close them in event of graffiti or other violations, such as drug use, or for repairs. Regarding tonight's items on layoff notices to employees, she noted that there is no budget item to speak of reduction of funds; many of these positions are catergorical and noticing is normal given the uncertainty of funding. In conclusion, Superintendent Baker welcomed all to the meeting.

### 6.0 HIGH SCHOOL STUDENTS BOARD REPRESENTATIVES REPORT

Mayra Gonzalez of Pajaro Valley High commented on the schools upcoming activities, including a club carnival, grad night, prom. Spring sports have started. The Ivy League project is fundraising to be able to tour the campuses. Interact club has been chartered and the school is establishing an ASB council.

Markus Serrano and Bianca Salgadillo of Watsonville High commented on a successful freshman registration event. The junior class is doing a fundraiser to replace Willie, the school mascot. They noted that summer school will be different this year as it will include opportunities to improve grades and provide alternative

classes to be ahead of electives such as music and cooking. These additional opportunities are possible due to the SIG grant. There are many activities and incentives to encourage students to improve their test scores.

### 7.0 POSITIVE PROGRAM REPORT

7.1 "Three of Our Own" are Honored by Pajaro Valley Chamber of Commerce: Rhea DeHart, teacher and former Board member; Diane Severin, teacher; and Gary Smith, Personnel Commissioner.

Report by Dorma Baker, Superintendent.

Dorma Baker commented that the three people recognized by the Pajaro Valley Chamber of Commerce at their annual awards dinner were all affiliated to the PVUSD community. She introduced Rhea DeHart, a teacher, PVFT president, and former board member, and Diane Severin, a teacher.

Rhea DeHart commented that she appreciated the honor and that she was happy to see so many students attending the board meeting as part of the WHS curriculum.

Diane Severin stated that she is fortunate to be doing the job she completely enjoys for 57 years.

Dorma Baker noted that Gary Smith is a great person in the community; he's was not able to attend this evening but we wanted to acknowledge his recognition.

Dorma Baker added that these individuals are great inspiration. She also added the PV Chamber honored Relay for Life for the American Cancer Society as the Event of the Year; many of the district's employees participate and make the event possible. Zenaida Castillo showed the award received at the PV Chamber and invited all to WHS on July 21<sup>st</sup> for the next Relay for Life event.

President DeRose closed the regular meeting and opened the public hearing.

8.0 PUBLIC HEARING ON WAIVER REQUEST: QUALITY EDUCATION INVESTMENT ACT (QEIA) CLASS SIZE REDUCTION FOR FREEDOM ELEMENTARY, MINTIE WHITE ELEMENTARY, OHLONE ELEMENTARY, STARLIGHT ELEMENTARY, E.A. HALL MIDDLE SCHOOL AND ROLLING HILLS MIDDLE SCHOOL, AND API (3 YEAR AVERAGE) FOR MINTIE WHITE ELEMENTARY AND E.A. HALL MIDDLE SCHOOL.

### 8.1 Report by Ylda Nogueda, Assistant Superintendent

Ylda Nogueda reported that PVUSD is requesting a waiver for 2010-11 and through 2013-14 to increase the class size targets for each of the schools listed. These schools were unable to meet the class size requirement due to district and state budget reductions. Some classes were at 22 and they needed to be at 20; others were at 27 and needed to be at 25. The District is hopeful that the waivers will be approved. In addition, the District will also request a waiver for API targets for Mintie White and EA Hall because there have been significant gains in the past three years for both schools. We are confident that with the approval by the Board, it will go to the state and it will be approved. She noted that about 10% of the schools in the state are in similar situation.

Ylda clarified that there is certainly no guarantee but that due to the number of schools in the state not meeting class size there is a possibility of the state approving the waivers.

<u>Michael J. Smith</u>, community member, spoke about smart meters and the possible health problems related to them; he expressed his concern for students. An opt-out measure is offered but only for private residences, not for public serve buildings, such as schools.

<u>Maureen Smith</u>, community member, spoke about the two initiatives circulating that would bring many dollars into the schools. She noted that she would bring both initiatives to the Superintendent so that the board can have information to support endorsing those initiatives.

Robin Butterworth of CSEA, is the new Political Action Coordinator for the e-board. She introduced the rest of the new officers: Leticia Oropeza – President; Victoria Borba – 1<sup>st</sup> Vice President; Esther Morillo – 2<sup>nd</sup> Vice
President; Marisa Hernandez – Secretary; Diana Martinez – Treasurer; and Zenaida Castillo- Chapter Public Relations Officer. She thanked the board for helping negotiate to bring back the 5 furlough days. Efforts to improve school funding are being made: SB81 went to the governor to return funds to local home to school transportation. CSEA will meet with Bill Monning on March 9 to discuss needs of public education. She mentioned a concern regarding resolution to lay off 8.5 classified employees, although it is the lowest number seen in a few years.

Olga de Santa Anna, PVAM, commented that testing time is approaching. She thanked PVAM for improved communication between administration and staff. She spoke about the responsibility of middle schools as they help adolescents through the tough decisions they face. Principals thank every teacher for their support, empathy and keeping their eyes in academic goals. She commented on a successful articulation day earlier and thanked Murry Schekman and Susan Perez for putting together a powerful afternoon of learning. Teachers in the classroom were all engaged. She thanked all Assistant Principals for facilitating each content area. Data team processes are not going away but rather will drive our schools move forward. There are efforts at the sites to help pass a bond measure to improve our facilities.

### 13.0 REPORT AND DISCUSSION ITEMS

13.1 Report and discussion on the Wellness Policy.

Report by Murry Schekman, Assistant Superintendent, Secondary Education.

Richard Puente, Coordinator of At Risk Students, reported that the Coordinated School Health (CSH) is a partnership between community and internal resources. He mentioned that there are direct benefits of school based health centers and academics, including increased school attendance, decreased drop outs and higher graduation rates. The CSH program includes: comprehensive school health education, family and community involvement in school health, school-site health promotion for staff, healthy school environment, school psychological and social counseling, school nutrition services and school health services. The following are community partners in health efforts: Salud Para La Gente, Go for Health, PVPSA, 5210 Project, Jovenes Sanos, Bicycle Safety, Dientes, CASA and Second Harvest Food Bank among many others.

Nicole Meschi, Food Services Director, stated that the district has a strong wellness policy. She offered statistics on breakfasts, lunches, snacks, infant and childcare meals and snacks, and cartons of milk served during 2010-11. She noted that department continues to offer salad bars and garden bars at some schools. In total, the department also purchased \$260,000 in fresh fruits and vegetables for all school sites. Schools also received: the Harvest of the Month, a local fruit or vegetable featured each month in the cafeteria; free breakfast in all elementary schools in Watsonville; and implemented Breakfast in the Classroom in four elementary schools.

Jen Bruno, After School Coordinator, reported on the physical education programs available for students in the after school programs to ensure the PE requirements are met. In particular, the Fitness 4 Life is a program that successfully combines physical activity and nutrition education.

Jen Bruno and Rich Puente commented further on the successes of district partnerships. A particular success, Rich Puente noted, was the implementation of the TDAP vaccination.

Rich Puente and Nicole Meschi reported on areas of continued follow up, including enforcing the wellness policy, fundraising with healthy items, and improve efforts on a healthy, clean and safe environment in spite of the budget difficulties.

Murry Schekman reported on Relay for Life, an event as an example of the district staff involvement in ways to promote health. Nancy Valdez of the American Cancer Society was present and commented

that she was proud to be part of the partnership with the district. Two cancer survivors and employees of the district, Ana Ybarra and Lupe Godinez, were present and commented on the importance of promoting healthier choices and supporting events such as Relay for Life. Lupe Godinez noted that this event raises awareness in our youth.

Albert Roman commented that the resolution includes mostly categorical or temporary contract positions. There are no general fund positions being laid off but rather these are funded through grants, categorical or other soft monies, such as donations. It may be that that most may come back but we have to notice in the event funds are not available.

Pam Shanks noted that administration will need to meet with classified employees at least 45 days prior to the end of the school year to notify them of possible options.

Outside of these two, there are about 18 FTE that are working with grant and categorical funds.
