President De Serpa called the meeting of the Board in public to order at 7:05 PM.

3.1 Pledge of Allegiance

Trustee Osmundson led the Board in the Pledge of Allegiance.

3.2 Welcome by Board President

Trustees Leslie DeRose, Maria Orozco, Karen Osmundson, Lupe Rivas, Jeff Ursino, Willie Yahiro and President Kim De Serpa were present.

President De Serpa welcomed all to the meeting.

3.3 Superintendent Comments

Superintendent Dorma Baker welcomed all to the Board. She reported she had attended the State Board of Education (SBE) public hearing to advocate for local control of district funds. Very happy to report that the advocacy efforts were successful and the LCFF was approved by the SBE.

3.4 Governing Board Comments/Reports

- Report on Standing Committees Meetings (limit to 1 minute per trustee)

Trustee Orozco reported that she had attended a college readiness event which was very successful. She was glad to report on the ongoing gang-prevention program and collaboration; these meetings are taking place through March at various schools.

Trustee DeRose reported on the positive experience of speaking in front of the SBE.

Trustee Osmundson stated she was looking forward to the presentation on arts. She noted that she regularly attends Adult Education Advisory Committee meetings.

Trustee Rivas said she attended the Migrant talent show and it was a great celebration. She went to Mexico City and took her 15-year old grandson and it was an excellent lesson about the culture and the people.

President De Serpa reported that she has been meeting with elementary staff to discuss concerns. She announced the loss of an Aptos High School student recently and stated that we all need to be sure we reach out to our students when something is perceived to be going wrong.

6.0 HIGH SCHOOL STUDENTS BOARD REPRESENTATIVES REPORT (5 min. per school)

Alondra Garcia-Mendoza and LaMaya Gross of Aptos High School reported on fundraising events, the success of the second harvest food drive, an upcoming club carnival, and the wonderful drama production at school.

Alondra and LaMaya also spoke about the devastating loss of a student and of student and staff efforts in supporting everyone.

Felicia Davidson of Pajaro Valley High School, commented on a successful visit of Denmark students, the Interact's club event to raise funds for Jacob's Heart, the upcoming spirit week and club carnival on Valentine's Day.

13.0 REPORT AND DISCUSSION ITEMS

13.1 Report and discussion on the Annual Williams/Valenzuela Legislation Status Report. Report by Dorma Baker, Superintendent.

Adam Wade, Curriculum and Instruction Coordinator, County Office of Education, gave a brief background on the 2000 Williams legislation, which requires adequate materials and facilities for all students. The report is now part of the Local Accountability Plan. Mr. Wade spoke about the process of visiting the schools and what they look at. Important to look at any school that rank below 90% in the facilities settings; the district does well in ensuring correction of items in a timely manner. Mr. Wade concluded the presentation by stating that 19 schools were visited, 20% of the visits are unannounced, and staff were extremely helpful.

Board participated with comments and question.

7.0 POSITIVE PROGRAM REPORT ON VISUAL AND PERFORMING ARTS

7.1 Report by Lyn Olson, GATE Coordinator

Lyn Olson began her presentation celebrating Susan Megorden, an Aptos Jr. High arts teacher, for having been the recipient of the California Art Education Association's Exemplary Program award. She asked Mr. Richard Detterman, Assistant Principal at AJrH, to elaborate on Ms. Megorden's program.

Mr. Detterman stated that with Ms. Megorden's program, students' art is being displayed at various locations, including at Mission Hill Middle School and the Aptos Jr. offices. The program is all inclusive and greatly benefits all students.

Ms. Olson commented on community partners that have made the arts program at the schools very successful: the Santa Cruz Arts Council (SPECTRA), the Santa Cruz County Office of Education, the Museum of Art and History and PV Arts Council, Watsonville Civic Plaza, and Cabrillo College and UCSC. With these collaborations, student art is displayed in key areas around the city.

A video of students speaking about the positive impact of arts in their life was shown. Ms. Olson presented information on where arts are offered and how those programs are funded. In addition to district funding credentialed teachers, funds come from parent organizations, the Tandy Beal Arts Alive program, SPECTRA, and the County Office of Education. It was noted that all teachers integrate arts as much as possible in their curriculum but some don't feel they have sufficient time or training to be as effective as possible.

In reference to Common Core (CC) Standards, Ms. Olson noted that the skills involved in arts are important to being successful in the CC. Arts and CC require deep and high level of thinking. The goal of CC is to have students who are college and career ready through creativity, collaboration, communication and critical thinking and arts provides plenty of support to master this goal. Professional development to bridge CC and the arts is taking place in collaboration with the COE, PVUSD VAPA, and Professional Learning Communities. Next step in professional development is to look at the standards that were developed by the National Coalition of Core Arts Standards to see if they will be adopted or if the current VAPA standards would be amended; a final review of these standards is expected to take place in June 2014.

Next steps to achieving equity in arts throughout the district is to update or rewrite the current PVUSD arts plan, which was developed in 2007. It needs to be updated to ensure it is aligned with CC standards, to include integration of arts in regular classroom through professional development, address funding sources, and include equity across the district in its implementation plan.

Public comment:

<u>Jerry Falek</u>, artist, commented on his experience as a teacher in special education and how it has taught him that there is a lot of correlation in learning and art skills.

<u>Susan Freeman</u>, teacher, spoke of the role of arts in education of English Learners as a powerful partner for language learning. She reported briefly on what research data shows on this matter.

<u>Susan Megorden</u>, teacher, stated that she was concerned about all students having equal access to the arts. Arts create an inclusive place, where all students come together and learn. We have inadequate funding in this district and arts can create a positive learning environment.

<u>Celeste DeWald</u>, volunteer for the Santa Cruz Alliance for Arts Education, gave examples of how school districts are investing in the arts: Los Angeles USD incorporated arts into the policies; Fresno Unified has equity and access to the arts for all students; and San Diego has increased student performance that is directly connected to their arts program.

Linda Cover, teacher, stated that science and arts work well together.

<u>Mary McLaughlin</u>, Santa Cruz Arts Coordinator, spoke briefly of the Summer Arts Institute, how it is funded and what the intent of the program is.

Board participated with comments and questions and thanked staff and community partners for their great work.

8.0 VISITOR NON-AGENDA ITEMS

<u>Sue Forson</u>, principal of Watsonville Charter School for the Arts, stated that it was great to hear about the efforts to incorporate arts into the district schools. She offered advice to have effective teachers: hire teachers who have arts background.

<u>Bill Beecher</u>, community member, commented on teacher preparation time and the importance of having this to do well. It seems that teachers should have enough time, with 28 hours to teach and 40-hours work week. With the increased state funding, the district should reinstate assistant principals.

<u>Guadalupe Alvarez Garcia</u>, Youth Now Program and parent, spoke about a free after school program for middle and high school students that provides enrichment programs as well as sports. The program is run by volunteers and there is a need to bring more volunteers. This is the program's 4th year and they are available Monday through Thursday, 3:00 to 5:30 PM.

9.0 EMPLOYEE ORGANIZATIONS COMMENTS – PVFT, CSEA, PVAM, CWA 5 *Min. Each* Sarah Henne, PVFT Grievance Officer, was happy to report that the union had ratified the tentative agreement. PVFT is looking forward to working in improving working conditions. Ms. Henne noted the union was pleased the district has begun the ongoing process of involving teachers in the LCAP. Teachers want to be more involved and there seems to be some inconsistency about how sites approach this. She reported that the Safety Committee had met today and will continue to meet; it is a positive way to address district wide safety concerns.
