1.0 OPENING CEREMONY – MEETING OF THE BOARD IN PUBLIC 5:35 PM

President De Rose called the meeting of the Board in public to order at 6:03 pm.

1.1 Pledge of Allegiance

Trustee Yahiro led the Board in the Pledge of Allegiance.

1.2 Welcome by Board President

Trustees, Doug Keegan, Sandra Nichols, Kim Turley, Willie Yahiro and President Leslie De Rose were present. Trustee Libby Wilson arrived at 6:06 pm. Trustee Karen Osmundson was absent.

2.0 APPROVAL OF THE AGENDA

Trustee Keegan moved to approve the agenda with the correction that the time listed on item 1.0 is incorrect and should be 6:00 pm. Trustee Turley seconded the motion. The motion passed 6/0/1 (Osmundson absent).

3.0 REPORT, DISCUSSION AND POSSIBLE ACTION ITEMS Note: Management and Classified Salary Schedules are attached for your information.

Public comment on job descriptions:

<u>Bonnie Tarabellini</u>, teacher, spoke in favor of class size reductions and against proposed increases because everyone has increased responsibilities but not rate increases.

Francisco Rodriguez, PVFT president, requested a cost analysis to show the savings to the district with raises.

Bobby Salazar, CSEA president, commented on how union members often perform extra duties.

Alexandra Klikoff, parent, spoke in favor of class size reduction and putting any extra funds into that program.

Peter Nichols, community member, spoke against the proposed salary increases.

As a preface to the job descriptions, Superintendent Baker spoke about the district restructuring efforts, including the combination of entire departments to afford savings to the District.

Ylda Nogueda, Assistant Superintendent, commented on the Stimulus Funds and the portion that is allocated for Title I schools, which includes all schools in the South and Central areas of the District. She mentioned that for one year, these Title I funds would cover the full time reinstatement of Library Media Technicians; funds that were identified in the General Fund for the 3.5 hours at each school would cover full time positions for schools in the North area of the District.

Dorma Baker explained the reasoning behind each job description.
